Board Seat Vacancies

The business decisions affecting Loft Ridge are made by a Board of Directors. There are no specific requirements to be a member and amount of time devoted depends on your level/areas of interest. Board members must consider the Community as a whole and not have a specific agenda. You will have input in creating a budget, make decisions regarding issues of non-compliance and ACC violations, review contracts and delinquencies, generate resolutions and oversee our committees.

Seven of your neighbors comprise the Board. There will be three seats open this spring. If you would like to be a candidate, consider attending the March, April and/or May Board meetings to see what's involved.

Elections will be held at the **Annual Meeting May 21, 2015.**

News from the Board

Doody Calls was contracted to empty the pet waste stations and tennis court/tot lot trash cans weekly for \$60 a visit. (We pay for the bags so please use your own). **Kelly Campagne**, a new owner on Cheatham, was appointed to fill a vacancy ending May 2016. An independent **auditor** has been engaged. A separate **group email** will be established for the sole purpose of advertising items for sale or give-away. Details will be finalized soon.

Parking at Our "Circles"

Our new police contact has clarified this issue. You can park nose-in at the circles as long as you don't impede access of emergency vehicles (or the snow plow). Better to be safe than sorry, so if you have a long vehicle, try to park at the center of the circle. If you're not comfortable, park on Ridge View Drive or Cannon Lane, remembering that when vehicles are parked on each side of those streets, two travel lanes aren't available.

Loft Ridge Porches

Only chairs or benches made of wood or iron are authorized on the front porches or stoops. Furniture is not allowed on common ground. No toys, children's wagons/cars or strollers are to be left overnight on front walkway or porch.

Re-Purpose Winter Sand

Sweep the sand from your parking space. Keep it stored in a container in your trunk in case you need it next winter if your vehicle gets stuck.

It is the time of year to build/replace fences and decks so please remember that wheeled vehicles are not allowed on common ground. We realize that it is an "inconvenience" but you are responsible for damage.

Grounds Contract Summary

Ongoing: - Mowing early Spring – late Fall every 7-10 days to a height of 3-4"

- Edging performed every other mowing

- Pruning of beds and tree saucers

- Herbicide treatment to walk, curb and hard surface weeds

Time TBD: - Pruning shrubbery, 2-5 times

Ground cover pruning, max 5 times

Spring/Fall: - Clean-up (removal of winter debris, prune deadwood) (Spring)

- Edge and mulch plant beds and tree wells (Spring & Fall)

- Fertilize trees, shrubs and ground cover (Spring)

- Pre-emergent weed control (Spring 2x)

- Cutback of perennials (Spring)

- Fertilization of grassy areas (Spring 2x, Fall 2x)

- Post-emergent weed control (Spring & Fall)

- Seasonal flowers in entrance beds (Spring & Fall)

- Necessary pruning to a height of 12' of deciduous trees (Fall)

- Turf aeration, liming, fertilizing and over seeding (Fall)

- Leaf removal (Fall 2x)

- Entrance lights out/malfunctioning/damaged
- Mailbox damaged
- Notices on mailboxes or light poles
- Pet waste stations overflowing
- Unsafe tot lot activity

- Tot lot damaged

Are you planning an exterior change?

Ask the Architectural Control Committee (ACC) if your intended change or construction is within guidelines by submitting the request form found at Exhibit A in the Handbook (www.loftridge.com, HOA, governing documents, handbook)

Be approved. The ACC has 30 days after receipt of your request to provide their decision by annotating and signing the request form.

Commence with your project. Please remember construction or material delivery vehicles are not allowed to drive on common ground. Call Miss Utility at 1-800-552-7001 before digging.

TRASH

Please Care

If you see trash on the common ground, please pick it up. This could be from someone's overflowing can or a walker who discarded an empty water bottle. No matter the source of these "eyesores," this is our neighborhood and its condition reflects on all of us.



Spring Cleaning - Document Dilemma

KEEP IT --- OR --- SHRED IT?

- **Tax Return:** keep for 7 years
- **Investment statements for taxable accounts:** once you receive yearly summary, shred monthly and/or quarterly statements
- Bank statements: keep for years when supporting tax returns, if not, shred after balancing account
- **Credit card statements:** keep when major purchase included in case needed for warranty or when charitable contribution is on statement. All others may be shredded once verified.
- ATM receipts: shred once verified against bank statement
- Cancelled checks: unless needed for tax return or other purpose, shred after 1 year
- Medical bills: keep at least 1 year unless supports a tax deduction then save with tax documents
- **Retirement plan contributions:** keep records of contributions to non-deductible individual retirement accounts indefinitely
- **Insurance policies, wills, birth certificates, citizenship papers, and other legal documents:** keep forever in a secure place (safety deposit box at bank or a fireproof box at home)

These guidelines are provided for information purposes only. It is recommended that you check with your insurance company, brokerage firm, government agency, lenders or creditors to find out if you should keep your records longer based on your individual situation. (Fairfax County publication)



Now that the Holidays are over, most of us are looking forward to spring cleaning and disposing of some of our "unwanted treasures." Habitat for Humanity's **ReStore** is now at 869 Pickett St. From Van Dorn, turn left at TD Bank and it's on the right two blocks down.

Shop 10am-5pm Monday-Friday, 9am-5pm Saturday. You could find cabinets, tools, appliances, sinks, toilets, electrical/plumbing parts, lights, fans, floor/bath tile, and small furniture just to name a few. Some of these are new, all are at huge discounts.

Tax-deductible donations are received at the rear of the store Monday-Saturday 10am-4pm. If you have large items to donate, just call 703-360-6700 or go online at habitatatnova.org to schedule a free weekday pick-up. They accept appliances less than three years old; cannot accept computer items or painted kitchen cabinets.

New Shopping Center Nearby

Hilltop Village Center, at the intersection of Beulah Street and Telegraph Road, will feature a **Wegman's** grocery store (slated to open in June) which will have an inside restaurant and a large take-out department. The site will also include a gym, retail stores, restaurants, banks, and adjacent recreational amenities including two soccer fields, a pavilion, a playground, an open play area as well as lots of parking.





New Discount Grocery Store

Aldi's opened at 6129 Backlick Road in Springfield in late February. It is in the shopping center across from Mike's American Grill, in the old Fischer's Hardware location. They accept cash, EBT, and most debit cards. No checks, credit cards, or coupons.

Expansion in Kingstowne

The parking lot by Bonefish Grille has been approved for building of four office structures, including an exception for a residential component. The mix of condos, apartments, and age-restricted housing has gone through rezoning but is in preliminary stages.

Want to Attract Birds and Butterflies?

Build on the beautiful location Loft Ridge offers us all, and turn your suburban garden into a welcoming space for birds, butterflies, and other native wildlife – help enhance the value of our urban green spaces!

The Audubon at Home Wildlife Sanctuary certification program assists homeowners (no matter how small your yard) in recreating and restoring your home's natural habitat by providing information on sustainable environmental management practices. Through the use of native plants, removal of invasive species, and the reduction of pesticides and fertilizers, you create a space for native flora and fauna. Audubon at Home ambassadors, trained Master Gardeners and Master Naturalists, will visit and consult with you on suitable native plants, landscaping, water retention, or other best practices.

The Memorial Day Poppy

Memorial Day is a day of remembrance for those who have died in service of the United States of America. Originally Decoration Day, it was designated in 1868 for the purpose of decorating the graves of soldiers who had given their lives in the Civil War.





We cherish too the Poppy red That grows on fields where valor led It seems to signal to the skies That blood of heroes never dies.



She conceived the idea of wearing a red poppy on Memorial Day and wore the first one. Shortly before Memorial Day in 1922, the Veterans of Foreign Wars (VFW) became the first veterans organization to sell the poppies nationwide.

National Moment of Remembrance

In observance of Memorial Day, a Resolution was passed in December 2000 which asks that at 3pm local time for all Americans *To voluntarily and informally observe in their own way a moment of remembrance and respect, pausing from whatever they are doing for a moment of silence or listening to "Taps."*

150th Anniversaries

Abraham Lincoln was assassinated on April 15, 1865 at Ford's Theater in Washington, D.C. just six days after General Lee ended the Civil War when he surrendered to General Grant at Appomattox, VA. Be on the alert for festivities commemorating these historic events.
